# Dear friends of All May See Foundation,

After a two-year wait to celebrate the 50th anniversary of All May See, and pay tribute to the contributions of Stephen D. McLeod, MD, Chair Emeritus, UCSF Department of Ophthalmology, and Kathleen Rydar, President Emerita, All May See, the event took place on Thursday, December 1, 2022, at the Chase Center. Over 150 distinguished guests including University of California and UCSF leadership, faculty, staff, donors, board members and friends gathered for a gala which culminated in a live concert featuring Italian tenor Andrea Bocelli. We raised \$230,000 for faculty vision research.

Once again UCSF Ophthalmology ranked among the top 10 vision care centers in the nation and Best in Northern California by US News and World Report 2023-24 Best Hospitals Survey. The Department offers both routine vision care and evaluation and treatment for a wide range of eye diseases, from common conditions to the most rare and complex. On December 1, 2022, Jacque Duncan, MD was named Chair of the Department of Ophthalmology, replacing Stephen D. McLeod, MD who became the Chief Executive Officer of the American Academy of Ophthalmology.

All May See Foundation awarded \$1.7 million in faculty and other awards to the UCSF Department of Ophthalmology and Francis I. Proctor Foundation.

With the help of many loyal and generous donors, All May See staff raised \$2.24 million to establish three new endowments: Stephen D. McLeod, MD Endowed Chair in Ophthalmology; Stephen D. McLeod, MD Leadership Lecture in Ophthalmology; and the Harry William Hind Professorship.

Deborah Chesky, All May See President and Rick Seefeldt, Director of Koret Eye Institute and UCSF Ophthalmology Faculty Practices, both had the honor of presenting at the esteemed World Association of Eve Hospitals — a global association where all member facilities are recognized as centers of excellence in ophthalmology.
